**ARC EXPLORATION RAISES \$1.5M
FOLLOWING COMPLETION OF PLACEMENT**

ARC Exploration Limited (“**ARX**” or “the **Company**”) is pleased to announce it has successfully raised \$1.5 million through an oversubscribed placement (“Placement”) of 7.5 million new fully paid ordinary shares at \$0.20 per share to institutional and sophisticated investors.

The Placement was approved by shareholders at an Extraordinary General Meeting held on 30 May 2018. The Placement puts the Company in a strong financial position to undertake exploration work programs at the Manitou Gold Project in Canada and to explore the Company’s existing assets.
